### SEC ASSIGNMENTS

SET UP IS 11:00 am. Police will provide a rolling closure during this rally which begin at 12 noon starting and forming at Fifth and Craft Avenues, proceed onto Fifth Avenue left onto Grant St and stop at the 414 Grant Street, City County Building for a rally. They will continue to proceed onto Grant Street left onto Fifth Ave, right onto Wood Street, left onto Liberty Ave, right onto 7th St and proceed onto the 7th St Bridge which runs onto Sandusky Street, Sandusky will run into East Commons, proceed onto East Commons and right onto East Ohio and into East Park. Due to the Secret Service perimeter, Sandusky will be closed at all times prior to 3:30 p.m. on Friday, September 25. As such, that portion of the march should be timed so as to coordinate with the opening of that street.

NOTE FOR ORGANIZER: DUE TO VEHICULAR RESTRICTIONS IN PLACE NO VEHICLES ARE PERMITTED PAST FIFTH AVENUE AND ROSS STREET. ENCLOSE IS THE CITY OF PITTSBURGH PARK RULES, REGULATIONS & GUIDELINES. PLEASE ALSO NOTE THAT DUE TO EXTREME SECURITY ISSUES, THE CITY MUST RESERVE THE RIGHT TO MODIFY THIS PERMIT ROUTE SHOULD THE HARD PERIMETER CHANGE PER THE SECRET SERVICE.
